

## PCE Europe Board meeting 12<sup>th</sup> October 2011

### **1. Approval of minutes.**

The minutes for July and September were approved.

### **2. European Association for Counselling - ( EAC) meeting in Florence**

Danae requested clarification on two main issues;

- The Collaboration of EAC and PCE Europe in the issuing of certificates.

The EAC wishes to seek the collaboration of PCE Europe in issuing its own Certificate. The EAC normally issues certificates to counsellors through the National Associations for Counselling in member countries. Where no National Association exists then they would like verification to come from organisations such as PCE Europe.

The board was clear that if someone approaches the EAC for a certificate where there is no National Association and they are a member of an organisational member of PCE Europe then we can be of assistance. If they are counsellors who are not members of a member organisation of PCE Europe then we cannot. The reason for this being that PCE Europe is there for counsellors and psychotherapists embracing the person-centred and experiential paradigm.

- Voting.

Questions on the place of the European Wide Organisations and voting on the EAC executive have arisen. The board is clear that at this early stage in restructuring we are there to provide support and assistance in forming good statutes and Bylaws the form of which cannot be predetermined. We gave our support to Danae to 'trust the process' and make the best initial decisions she could.

Danae and Simone Anderhub will attend together and be on different working groups.

It was suggested that Simone could join one of our board meetings to contribute to the ongoing work with EAC.

### **3. Payment for PCE Europe certificates.**

A question had arisen that if a practitioner had been awarded a certificate for counselling and then became eligible for a psychotherapy certificate would the certificate be charged for. The board agreed that it was a new certificate and should be paid for. It was also clarified that if a practitioner had been refused a certificate then there was no refund.

**4. Letter to our members about the PCE world conference.**

Willi drafted a letter to our members to encourage them to be involved and participate in language pools and make others aware that these are being encouraged to facilitate their attendance.

The letter was agreed.
